Purposes of the processing

The data are processed for purposes functional for the carrying out of our activity and the activity of our subsidiary and/or associate companies, specifically: web-based interface service delivery; provision of goods and services; commercial information; marketing activities; information activities; creation of professional profiles related to clients / customers or suppliers.

Communication and data dissemination

The personal data supplied by the user will not be disclosed. Personal data may be communicated and processed by third parties (credit card issuing institutions, courier/shipping companies that provide services instrumental to satisfying the user's requests. The data are not transferred to non-EU countries, in the absence of guarantees under Article 45 of the European Regulation (EU) 2016/679.

Duration of the Processing

The duration of the processing is limited to the carrying out of the requested services and by the retention period of the related documents due to fiscal, administrative, legislative obligations. The processing is proportional, limited, not excessive.

Place of processing

The processing connected with the web services of this website takes place at the same company in each of its territorial locations.

INFORMATION NOTE ON PERSONAL DATA PROTECTION AND CONSENT REQUEST FOR PROCESSING
